Authorization Agreement for the PRE-AUTHORIZED DEBIT PLAN



I/We authorize Canadian Niagara Power Inc. CNPI may not assign this authorization, whether directly or indirectly, by operation of law, change of control or otherwise, without providing at least ten (10) days prior written notice to me/us.

I/We have certain recourse rights if any debit does not comply with this agreement. For example, I/We have the right to receive reimbursement for any PAD that is not authorized or is not consistent with the PAD Agreement.
